INPEX to Strengthen LNG Marketing and Legal Functions through Internal Reorganization

TOKYO, JAPAN - <u>INPEX CORPORATION</u> (INPEX) announced today that it will further strengthen its LNG marketing related and legal functions through the reorganization of its Global Energy Marketing Division and New Ventures Division effective July 1, 2017.

This move reflects INPEX's initiative to enhance its management structure in the pursuit of the company's three growth targets outlined in the Medium- to Long-Term Vision formulated in 2012, which are the enhancement of its E&P activities, the strengthening of its gas supply chain and the reinforcement of its renewable energy initiatives.

1. Establishment of "LNG Trading Unit"

- (1) The objective of establishing the LNG Trading Unit is to steadily improve the flexibility and efficiency of business operations relating to the regulation of the LNG supply and demand across the company's gas supply chain, as well as LNG transportation. These business operations including LNG trading and transportation from company's projects outside of Japan have until now been carried out in part by the Gas Business Unit of the Global Energy Marketing Division.
- (2) The LNG Trading Unit will be a subdivision of the Global Energy Marketing Division.
- (3) The reorganization is scheduled to be in effect on July 1, 2017.

(4) Appointment of General Manager, effective July 1, 2017.

2. Estabishment of "Legal Unit"

- (1) The Legal Group, which is currently a part of the Business Development Unit within the New Ventures Divison, will be restructured as a standalone unit in order to further strengthen the company's legal functions including enhanced support for the company's business operations in Japan and around the world.
- (2) The Legal Unit will be a subdivision of the New Ventures Division.
- (3) The reorganization is scheduled to be in effect on July 1, 2017.

(4) Appointment of General Manager, effective July 1, 2017.
